SUMMARY

- 1. In order to improve service levels and results, constant evaluation and proactive actions are taken. The major difference in Epping during 1 July 2012 to 30 June 2013 was the installation of 4 additional cameras to support the Law Enforcement and the ECID security officers, bringing the total number of cameras to 16.
- 2. The additions to the camera system were the major project for the year.
- 3. The continued sponsorships towards the Epping Law Enforcement officers has been phenomenal, the ECID is the only Improvement District in Cape Town to obtain the amount of funds pledged to a total of R 1 332 602.55 ex vat for the period 1 July 2009-30 June 2012.

SECURITY REPORT

The security service provider has continued with a positive vision in the new financial year.

With the placement of the new vehicles and quad bikes, an increase of prioritized crime prevention played a vital role, the focus being to ensure the safety of all tenants and patrons entering the Epping Industrial environment.

As we are continuously faced with challenging situations namely an increase in unemployment, the task becomes increasingly difficult on a daily basis. As with the previous year, we have noted an increase in theft and attempted theft off premises and we have stepped up procedures to ensure that this does not increase further.

Theft off premises has become a common crime, so we urge owners and tenants to assist by "cleaning up" their yards and premises and locking their gates.

Through confirmation from the local SAPS Stations, the ECID has stepped up its crime prevention measures. By doing so, the ECID security has been proactive in ensuring that all suspects and unwanted persons in the area are profiled by SAPS. In doing so there is the possibility of picking up wanted criminals. We have noticed a decrease in the number of muggings in the area.

The quad bikes continue to monitor the rail track area, they stop and search people and respond to activity picked up by the cameras. The quad bikes are seen as an integral part of the ECID Security efforts.

Overview

The ECID Security force now consists of 4 vehicles, 2 quad bikes and 16 cameras. The costs are similar to the previous year, indicating that members are receiving an enhanced service. We continue to focus on ensuring Epping is a clean, safe and secure environment in which to conduct work/business.

CLEANING

Due to activity in the area, the number of cleaning staff stays the same. Clean-up crews are constantly working the areas of Bofors Circle from Tripper Way to SA Metal and Gunners Circle by the Informal Market.

The ECID constantly requests Cape Town's Solid Waste Department to clean up the rotten fruit at the informal market.

Princeton Services finished in December 2012 and Essential Cleaning took over on 3 January 2013.

There is now a full time supervisor who is in daily contact with the ECID office. The bags are taken to the City of Cape Town's Solid Waste Management site in Athlone twice a week, thus eliminating the use of the 30 cube skips.

The difference is that now 75% of the waste is recycled, leading to a dramatic decrease of waste being taken to landfill.

LAW ENFORCEMENT

We are faced with ever altering and extremely diverse demographics in the area and are continuously dealing with new challenges. With this in mind we strive to continue focusing on improving service delivery.

The ECID Law Enforcement has attended in excess of 2335 incidents. These incidents are indicated on the stats page, highlighting a wide range of incident types.

Over a period of four years, Law Enforcement has positively impacted on the Epping area although fines generated are less than the previous year.

The area from the N2 approaching Washing Drive in Langa has been identified as a hot zone for smash and grabs and 22 incidents occurred in June which lead to several joint operations with SAPS. The ECID Law Enforcement has assisted Pinelands and Elsies River SAPS to perform numerous public awareness programs in the Epping area. Every effort is made to ensure that owners, tenants, staff and visitors to the areas experience the safety and security of Epping.

Informal Market

The ECID Law Enforcement has been handed a verbal instruction by senior management to step back and keep a low profile with the informal market. All operational directives regarding the informal market will be dealt with by the City's Informal Trading Unit along with the assistance of various departments in Law Enforcement, Metro Police, SAPS and the Traffic Department.

The items listed below are items dealt with by the Informal Trading Unit;

- Overtrading
- Dumping
- Sauattina
- Illegal packing and stacking of crates.

The ECID Law Enforcement will continue to enforce Non-Moving Traffic violations;

- No number plates
- No license disks
- No PDP's

CAMERAS

With the installation of the fourth phase of cameras, we effectively moved towards a more readily proactive force.

The installation of phases one and two's cameras posed many questions as to their effectiveness; however each additional phase has definitely put a lot of minds at ease producing positive results. The success with the cameras has been astounding boasting a vast array of arrests and interventions.

This public space surveillance solution includes 16 high zoom 360° PTZ cameras strategically positioned in various parts of Epping.

These PTZ's are linked to Myertal's 24/7 manned and managed offsite security control room facility. The ability to instantly dispatch the vehicle or quad bike response teams makes this a truly proactive solution. With over 2,500 CCTV identifications with initiated dispatches to suspicious activity in the 07/2012 – 06/2013 year (12 months), this accounts for suspects that were proactively questioned, suspects removed from the area, weapons seized, stolen copper recovered, illegal fires prevented, medical emergencies detected and support provided.

This is all powered by state-of-the-art monitoring technology, a highly dedicated management and control room team, in collaboration with a highly effective vehicle and guad bike security unit.

MARKETING & COMMUNICATION WITH MEMBERS

Lizette Johnstone carried out 790 company visits, sent out 33 bulk emails to over 1000 people on the database, placed 27 articles on the website and attended 20 meetings with Council officials.

Brochures, posters, emergency procedure booklets and 2014 calendars have been compiled for distribution to companies.

Ryan Ord carried out 300 company visits and attended 16 Sector Police meetings, 20 SCCF meetings with SAPS, 11 SAPS/Vanguard smash & grab meetings and 23 railway infrastructure & security meetings.

The ECID has a total of 263 members.

GARDEN COMPETITION

Congratulations to GlaxoSmithKline, the winner of the garden competition for 2012. GSK received a R 500.00 Stodels gift voucher and the floating trophy for 2012 in recognition of maintaining a flourishing garden.



SOCIAL RESPONSIBILITY

The ECID collects recyclable materials which are then sold and the money donated to the Cart Horse Protection Association and the Animal Anti Cruelty League, a total of R 1055.00 was donated to each organisation.

The ECID also assists the CHPA by identifying overloaded horse carts, incorrect harnessing and lack of horse shoes and reporting this to their inspectors and assists the AACL by taking in stray or injured animals where possible or reporting such cases to their inspectors. Both these organisations are based in Epping 2.

The ECID, in conjunction with Premier Foods, Giant Sweets, Bokomo Oats and Capepots do a monthly distribution of food packages to the SOS Children's Village in Langa and the Church of the Nazarene in Bonteheuwel who have a soup kitchen and distribution scheme.
